I certify that the contents of the application form and all supporting documentation I submitted to Sally's Play Centre for consideration of daycare services are correct and accurate. I understand and agree that my dog(s) must be current on vaccinations, including Distemper, Hepatitis, Parvovirus, Parainfluenza, Rabies and Bordetella, and that proof of vaccinations must be submitted with my application and updated yearly thereafter.

I understand that dogs engage in various behaviours, actions and responses such as walking, running, barking, growling, snapping, biting, licking, sniffing, urinating, defecating, vomiting, jumping, lunging, rolling, playing, wrestling, chasing and swimming ("Activities"). I further understand that my dog(s) may sustain or cause harm, loss, damage, death, illness, infection or injuries such as cuts, scratches, bites, bruises and sprains as a result of the Activities despite all dogs being carefully supervised at all times.

I am fully aware of the risks and hazards associated with the Activities, and hereby assume any and all responsibility for my dog(s) while they attend Sally's Play Centre where the Activities take place.

I understand and agree that I am responsible for picking up my dog(s) from daycare prior to the close of daycare hours. Failure to do so will result in being charged late fees at the sole discretion of Sally's Play Centre. I also understand and agree that if I do not arrive to pick up my dog(s) prior to the close of daycare hours, I may not be able to pick up my dog(s) until the next business day. I understand and agree that all outstanding fees and charges must be paid prior to or at the time I pick up my dog(s).

I understand and agree that neither Sally's Play Centre, nor its owners, shareholders, directors, investors, sponsors, managers, affiliates, employees, volunteers, contractors, representatives and agents are responsible for the safety and well-being of my dog(s).

I understand, agree and authorize that if my dog(s) is in the care and custody of Sally's Play Centre for daycare purposes, staff may contact or transport my dog(s) to my veterinarian or any other accessible veterinarian as deemed reasonable and necessary should any injury or illness arise requiring medical attention. I further understand and agree that I am solely responsible for any medical expenses incurred for my dog(s) while under the care and custody of Sally's Play Centre.

It is my express intent that this waiver of liability agreement shall bind my heirs, assigns, executors and personal representatives if I am deceased, and shall be deemed as a release, waiver, discharge and covenant not to sue Sally's Play Centre, its owners, shareholders, directors, investors, sponsors, management, affiliates, employees, volunteers, contractors, representatives and agents.

This liability waiver agreement shall be governed by and construed in accordance with the laws of the Province of Alberta. I attest that I have read and fully understand the rules herein for daycare services at Sally's Play Centre and that my signature below indicates that I will abide by the rules in their entirety. I further attest that I have reached the age of majority in the province of Alberta.
